We will not communicate booth locations ahead of the festival, but will give you that information on Saturday morning when you arrive. **Cancellations**

Cancellations made prior to July 1<sup>st</sup>, will receive a full refund. No fees will be refunded for cancellations made after July 1<sup>st</sup>.

**Rules and Guidelines for Exhibitors**

1. Exhibitors are responsible for bringing all necessary display equipment including tents, tables, and chairs. No tents, tables, or chairs will be provided.
2. Booth spaces will be designated and assigned by the promoter.
3. Tables should be covered to the ground.
4. The promoter reserves the right to expel any exhibitor whose booth is, in the promoter's opinion, not in keeping with the standards established for the Festival.
5. All exhibitors are required to have a valid Maine Sales Tax certificate. Collection and remittance of Maine sales tax is the responsibility of the exhibitor.

6. Exhibitors are responsible to ensure no hazards exist in their booth and the area immediately adjacent to it.
7. The consumption of alcoholic beverages and smoking is prohibited except in designated area.
8. Music is allowed in booths, but consideration for other booths and area attractions must be maintained.
9. Set up begins at 7:00 am and your car must be unloaded and off the festival grounds by 9:30 am. You are required to stay until 3:00 pm, but are welcome to stay until dusk. You will need to indicate on your registration form if you are willing to stay.
